Subject of the Conference

For more than a decade, Algeria has been pursuing strategic options that give performance to a development model based on the opening of the national economy and the promotion of the private sector as an engine of growth, as well as the rational exploitation of the country's natural resources. The development of national economies has become highly connected to the rise and diversity of exploited, mineral resources, which have become a source of growth and increased operating.

This has made the focus of most public policy objectives focused on finding the most effective ways ensure the rational exploitation of those resources and investment in various mining activities that can have a positive impact on national economies.

Due to the importance of mining activity, the Algerian legislator issued several legislative texts to promote this sector. As a result, Law 0110- was issued on 03/02/2001/07/. As a result, the scope for investment in the mining sector opened by granting many incentives and removing some of the obstacles to investment, with the aim of attracting foreign and local investors alike.

The Act was amended by Law N ° 145- of February 2014, which defined various provisions relating to the manner and procedures of granting licenses, and granted tax incentives to major investors, such as exemption from the value added tax on equipment and materials for such activity.

However, a closer look at the state of the mining sector in Algeria believes that, despite the fact that the latter has a diverse geological structure that has made it possess several mineral wealth, which, according to experts, exceeds 1000 underground mineral materials, the mining sector in Algeria is currently producing a waste value.

The conditions for participating in the conference

- _ The research presented to the forum must meet the following conditions:
- _ Researches meet the requirements for scientific publication recognized in well-established scientific conferences.
- _ Not have already been published in a scientific journal, or have been exposed in the activities of another conference.
- _ Research (A4), Simplified Arabic, 14, for Arabic language, and Times New Roman, 12, For French and English languages, 1 cm between lines, 3 cm (cm) each for the edges of the paper.
- _ The size of the calligraphy in tables for Arabic research is 12 and for research in other languages is 10.
- _ The search is attached to its first page with the researcher information: The name of the researcher, his scientific rank, his organization, his email address, phone number, the title of the research and the theme he belongs to.
- _ The search in Arabic, French or English, where the researcher begins with two summaries, one in the Research language and the other in a different language, the size of a font (12) for Arabic and (11) for a

_ foreign language. The number of each one's Word shall not exceed 200.
_ The annexes and list of references and indexes are included at the end of the search. Similarly, accents are automatically inserted below the pages (footnotes) for each page, with a font (10) for Arabic type and a font (09) for foreign-language typing.
_ The number of search pages does not exceed 16, including the Finder Info page, reference pages, and do not accept research papers with more than one participant.⁰² It is necessary to determine which participant will intervene in the conference: in the event of bilateral participation.

Publishing research papers

All the research papers submitted to the conference: will be judged, and the best will be selected by the scientific committee to present at the conference:.. They will be published after being seized by the owners of the papers in an internationally numbered scientific book (ISBN),
